Figure 1a: Trade balance in percentage of GDP, 2008

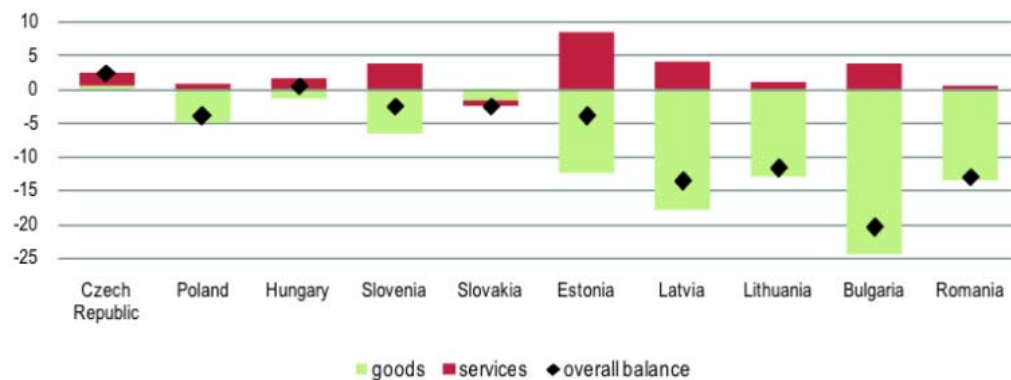
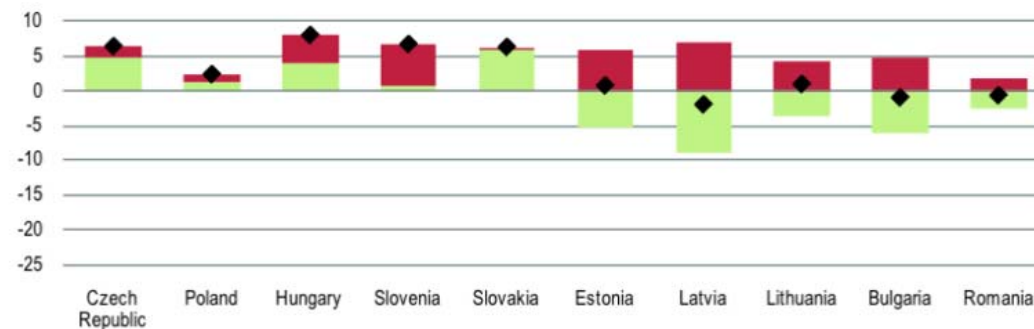


Figure 1b: Trade balance in percentage of GDP, 2013

Figure 3a.: Increase of Extra-EU exports

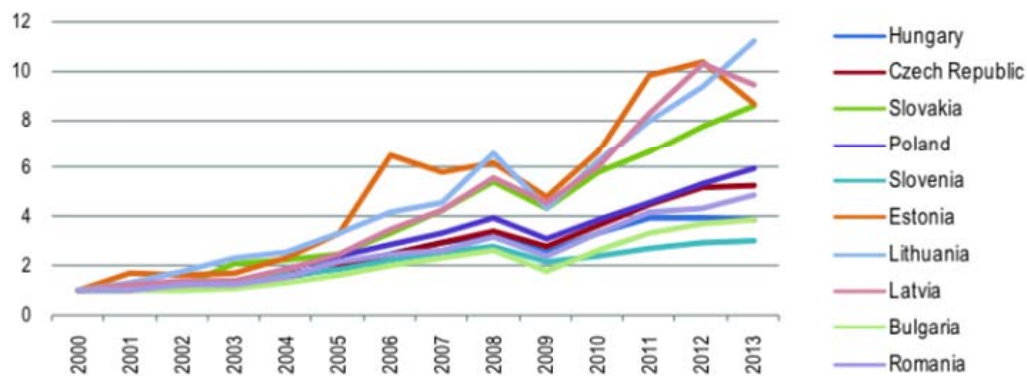
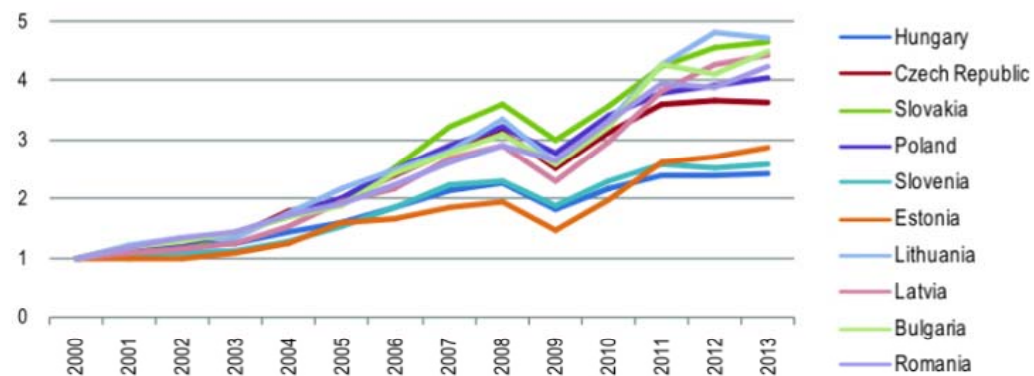


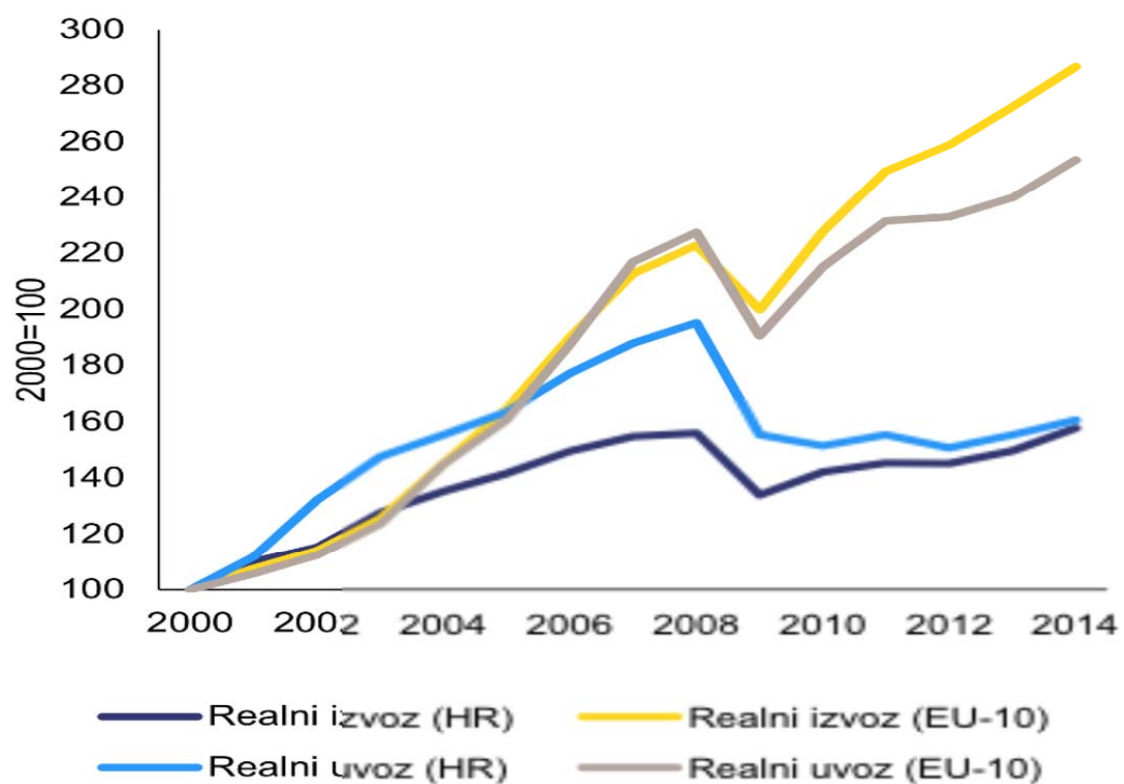
Figure 3b.: Increase of Intra-EU exports

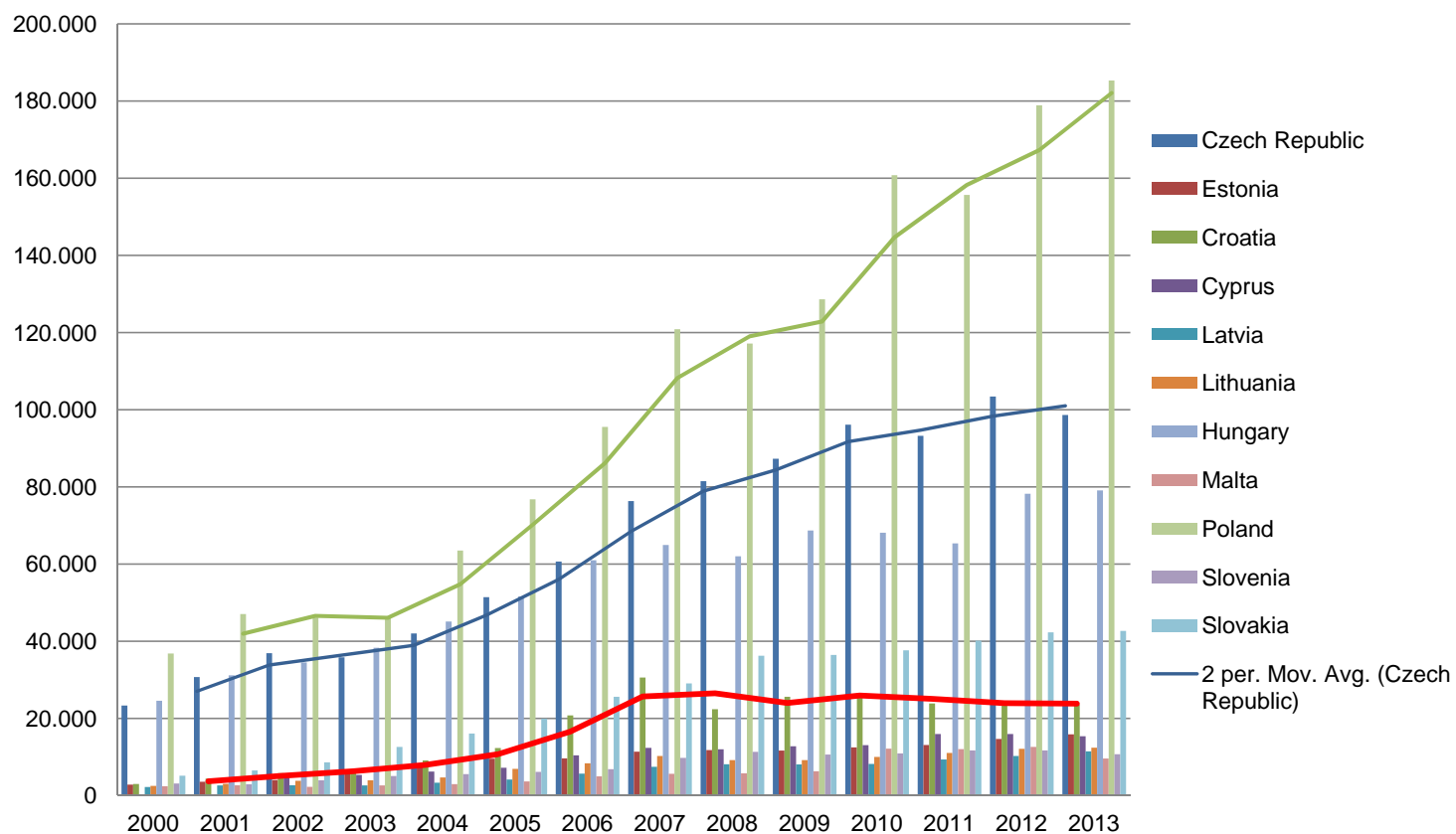
Realni uvoz i realni izvoz u Hrvatskoj i EU-10

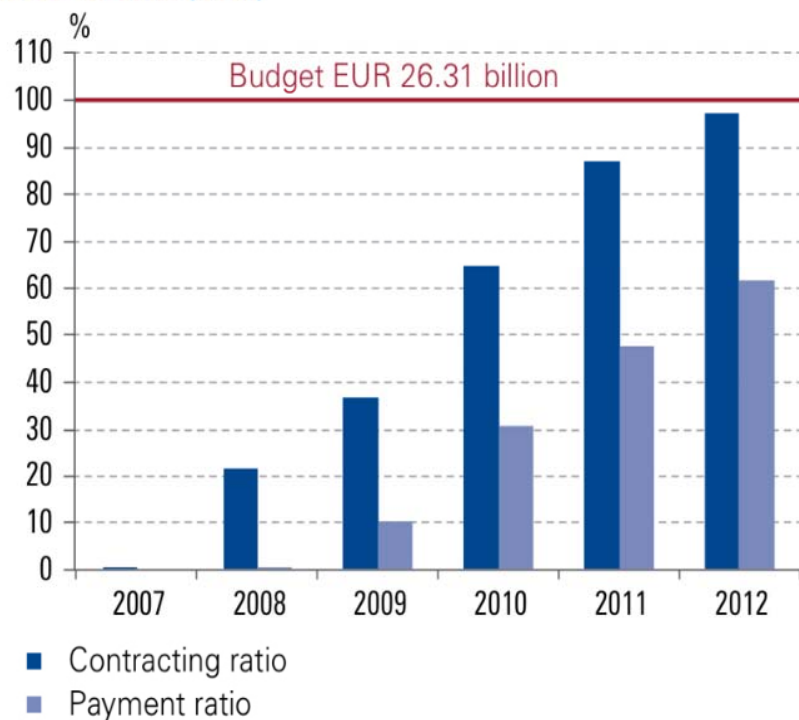
