EU-LAC Business Round Table
Information Note (08.06.23)

The **EU-CELAC Summit** between the EU and Latin America and the Caribbean, will take place on 17-18 July 2023 in Brussels. It is the first summit of Heads of State and Government of the two regions in eight years. It will be an opportunity to bring together in **two side-events** ahead of the Summit, a wide range of actors, including from civil society, youth organisations, local authorities, businesses, financing institutions and government.

EU-LAC Forum – Partners in Change,

An EU-LAC Forum, including a Youth Day, will take place on **13-14 July**. It will bring together **non-state actors, youth representatives and local authorities** to discuss opportunities to build a sustainable and inclusive future for both regions.

Topics will include **social cohesion**, inequalities, education, fair work, health, culture, youth, human rights and democracy, but also **sustainable and inclusive economic development**, and the impact of the global green and digital transition. Special attention will be paid to gender equality, indigenous and disability issues. **One entire day will be devoted to youth**. Youth will be addressed in the other parts of the programme as well.

The Forum should lead to closer cooperation between non-state actors and youth organisations from EU and LAC. It should also **formulate recommendations for the Summit** and the Business Round Table on sustainable and above all inclusive, economic development.

Business Round Table

Right ahead of the main Summit, the European Commission will organise a Business Round Table on **17 July** jointly with the Inter-American Development Bank (IDB) and CAF – Development Bank of Latin America.

The **EU-LAC Business Round Table** will bring together political leaders, business CEOs, heads of development financing institutions, and industry associations to review the key strands of the **Global Gateway Investment Agenda**. Global Gateway is the EU's offer to bridge the existing investment gap in the area of fair green and digital transition, by using public financing to leverage private capital and investment for projects that deliver on key public policy objectives.

In seven round tables, participants will explore **opportunities for investments** in, amongst others, renewable energy and green hydrogen, critical raw materials, decarbonisation, and transport infrastructure projects, 5G and last-kilometre connectivity, digitalisation for public services, and sustainable finance and green bonds.

The Business Round Table will also address **social issues** related to investments opportunities, such as the promotion of decent jobs and formal employment, education and vocational training, gender equality and corporate social responsibility.

The Business Round Table will be a **small-scale, high-level event with a maximum of 150 participants, by invitation and in-person only**. It features a general opening session, seven parallel round tables and a closing event just ahead of the main Summit which should allow for key messages to feed into it.
